

# On Mission in Ghana:

## You impacted thousands with the life-changing love of Jesus



Thanks to your support, the 2016 Kumasi Mission in Ghana was a massive success with 19,000 people hearing the Gospel and 2,865 accepting Christ! Together with you, we aim to bring the Gospel to people wherever they are. So, during our mission weeks, we held hundreds, sometimes thousands, of small meetings to share the love of Jesus with people at every level of society, all across the city.

In Kumasi, one of AE's evangelistic teams was invited to share the Gospel with a group of 25 car mechanics gathered together by a local auto-shop owner called Master Ben.

Master Ben is a Christian, so when he heard our Kumasi Mission was coming, he said, "I was very excited. I want the men here to know Jesus. I just don't always

know the best thing to say."

When AE's team arrived ready to preach, Master Ben couldn't stop smiling – his many years of hoping and praying for his workers to meet Jesus were finally becoming a reality. The main preacher, Guide Makore, told the men about the Prodigal Son and explained that God is a God of second chances. "He's waiting for you with open arms," Guide said. "No matter what you've done, come to Jesus and He will welcome you. You can have a new life in Him."

That morning, 18 young mechanics decided to follow Christ. Your generosity helped bring the Gospel to them right where they were – in a little outdoor 'church' under a mango tree.

# Transforming youth through Foxfires:

## You're setting young African hearts on fire for Jesus

There are over 200 million young people in Africa who need to know the love of Jesus. So, together with you, we're training teams of young men and women – called 'Foxfires' – who are passionate about spreading the Gospel of Jesus Christ to youth. Their mission is to bring Jesus to the very youngest strata of society, because no one is too young to put their faith in Jesus!

Thanks to you, these 'Foxfires' teams are being trained in:

- Creatively Preaching the Gospel
- Providing Life Skills for Youth
- Equipping Leaders to Serve
- Mobilising Youth for Missions

With your help, our 'Foxies' have been hard at work in countries like South Africa, Malawi, Zimbabwe and Kenya, participating in city-wide missions and sharing the Gospel with children and youth in churches and schools. Theto, one of our Foxies who's been serving in South Africa in 2016, explains:

*"We spread the Gospel creatively in dancing, drama, testimony and poetry. Also, you go to school and teach life skills that help young people deal with daily challenges."*

Douglas, another Foxie says:

*"I saw God doing great things in people's lives as we ministered the Word of God in school, churches and on the streets of Harare and sometimes in the rural areas. I've seen people giving their lives to the Lord, being set free from demonic oppression, being healed from sickness, and young people being delivered from drug abuse."*

As you've helped support our teams of Foxfires, you've been empowering future generations of children to know Christ, and to live transformed lives full of joy and spiritual freedom. Thank you!

# Peace and Reconciliation in South Sudan: You're bringing hope to people wounded by war



Many people in South Sudan have been left deeply hurt, angry and afraid as a result of the civil war and ethnic violence that's robbed millions of their homes and loved ones. But together with you, AE is bringing hope and healing by actively engaging with leaders and running workshops – all to promote peace-building and reconciliation.

Thanks to your support, many lives like these are being transformed through AE's Peace and Reconciliation workshops and mentoring:

Malish says: "The loss of my brothers during the violence left me feeling alone and distraught. Because of the training I've received here, I've learned that God is in control and I feel free from the heaviness that has covered me. I pray that AE continues this kind of training to spread the news of peace and unity in South Sudan."

Another workshop student named Immanuel says: *"What's happened here [in South Sudan] has broken my heart. The Peace and Reconciliation trainings by African Enterprise ... gave us better understanding about the root cause of the violence and how to change it. The AE facilitators challenged us to be agents of peace in our communities. Tribal differences are our default setting here in South Sudan. We have to learn to change our mindset about these things and without the help of AE it would have been impossible."*

And a pastor said of AE's training: *"I am now conscious that peace can only start within me."*

Thank you for your partnership to press forward for peace and reconciliation in South Sudan. Together, we CAN see this war-torn nation restored!



# You're giving vulnerable women new hope for life



Together, we've helped over 600 at-risk women in Malawi, Ghana, Kenya and Rwanda through AE's Vulnerable Women Projects by teaching them marketable skills and sharing the Gospel with them. In 2016...

- **You helped rescue 80 women from poverty and prostitution** by sharing God's love and by training them in tailoring through AE's Vulnerable Women Project in Malawi. Patricia, a former prostitute now learning sewing skills, says:  
*"Jesus has transformed my life! I'm certain that, if I had not left [prostitution] when I did, I'd have been dead by now. This school is leading*

*my life and many others to spiritual and economic transformation. Thank you for making this possible!"*

- **You also gave new hope to 25 vulnerable women like Esther** through the Kenya Mathare Women Empowerment Project. Esther says:  
*"Through these skills, my life will be transformed! I'm hoping to start a dressmaking and embroidery business. I'll also create opportunities for other women to learn from me. May God richly bless you."*
- **And you empowered 200,000 women to build a better future for themselves** through AE's weekly Self-Help Groups

in Rwanda. Many women here struggle alone through difficult circumstances, but these groups strengthen them to step into their God-given potential. A group member named Redempta says:

*"We were a poor family. When I became member of a Self-Help Group, I started contributing significantly towards the welfare of my family. We were able to [install electricity] and running water in our house. It's a great joy because we used to travel around five kilometres for water."*

Thank you for showing God's love to these women!

# Meet Daniel, one of the 200 pastors who you helped equip to transform Africa!



AE is passionate about training African pastors to understand the context of the Bible and train their church members to do the same. In 2016, 200 local pastors graduated from theology courses run by Anglican ministers.

Among those pastors you helped train was Daniel – a young evangelist in Ghana who has recently completed a Preliminary Theological Certificate (PTC) and says:

"PTC Course is the greatest thing that has happened to me in my life! Before I attended PTC, I used

to preach the Bible any way I saw fit. I'd read a passage, interpret it however it struck me and then go into the streets to preach. Now I see that I was full of superstition and judgement.

"Now I understand more fully how the whole Bible points to Christ and God's plan to reconcile humanity to Himself. I can now see that God will never drive anyone away from Himself. In fact, when we stray He always finds a way to bring us home.

"Now when I preach, I don't shout at people anymore. Instead, I speak

to them like friends and tell them about how good God is and how much He loves them.

"I hope to study further and do more to change the mentality of some African preachers who often preach things that are not at all aligned with the Gospel. Thank you for providing me with the opportunity to learn such precious truths about the Bible."

Thanks to your prayers and financial support, many more pastors like Daniel are being equipped to teach God's truth lovingly and powerfully.

- You helped protect 72 slum-dwelling families from disease by providing clean latrines through the Kenya Korogocho Latrines Project.
- You helped provide clean water to 700 people through the Rwanda Water Project.
- You helped provide apprenticeships for 17 young people like Alex, through the Ghana Apprenticeship Project. Alex says:



# How you helped transform lives in 2016

**Alemtsehay Zewdu lives in a house made from mud and bamboo sheets.**

**“Whenever the rainy season arrives, I get scared because the rain slips through the holes on the roof sheets and falls on my bed and where my two children sleep,” she said.**

**She lives in a shanty town in one of the poorest areas of Ethiopia. As part of its 2016 mission, AE helped fortify and rebuild her home, and the homes of other vulnerable, and elderly people in the town.**

**“I am happy now that some of the rooftop sheets are changed with new ones,” she said. “Now I will not be afraid of the rainy season. I raise my hands upwards to thank God.”**

**The mission team also served lunch to 150 street children over the course of the mission, telling them about Jesus and showing them His love. Thirteen of these young boys and girls gave their lives to Christ.**



## Get to know your National Team Leaders in Africa

### **Democratic Republic of the Congo (DRC)**

#### **Mr Leonard Kiswangi**

Leonard has been AE Team Leader for DRC since 2007, and has looked to expand the DRC office to engage in local work, as well as missions to other locations including Madagascar and Soweto. He worked as Communications Officer and Administrator for the DRC office, as well as working in AE Peace and Reconciliation projects before 2007. As Team Leader, he's involved in preaching, teaching at Kinshasa University and working to ensure peacemaking and reconciliation become a reality in DRC. He is eager to keep learning how to better serve the Lord and make an impact within his generation, in his nation and beyond. In DRC, there is an active Foxfires Youth presence, and an ongoing Peacebuilding and Reconciliation program.

### **Ethiopia**

#### **Dr Melisachew Mesfin**

Melisachew became AE Team Leader for Ethiopia in 2003, after over 20 years of working as an economist. He spent about 17 years in the Ethiopian Ministry of Planning and Economic Development working as an economist, and in the latter seven years as Team Leader and Department Head. While working with AE, Melisachew has pioneered a student discipleship program for upper primary to adult children, entitled Building the Church of Tomorrow, Today. His passion is to see the expansion of God's kingdom on earth by developing spiritual leaders. There is a strong discipleship program and Foxfires Youth Team in Ethiopia.

### **Ghana**

#### **Rev Bernard Sachie**

Bernard joined AE Ghana in 2003 as Project Manager and Accounts Officer, moving to a Mission Coordinator role in 2010 before becoming Team Leader in 2014. Prior to working with AE, Bernard worked as a school tutor, and later as a pastor of Grace Community Church in the Brong Ahafo Region of Ghana. Bernard has a particular heart for teaching and mobilising people for evangelism and, as a result, he's been involved in coordinating multiple conferences across Ghana and wider Africa, including the AE focus mission for 2016 in Kumasi. Notable projects in Ghana include the Street Children Apprenticeship Program and a Women's Rehabilitation Project.

## **Kenya**

**Rev Dr Stephen Mbogo  
(International Team Leader and International CEO)**

Since 1992, Stephen has served with AE Team in Kenya, first as Youth and Missions Coordinator, and from 2000 as Team Leader for Kenya. In 2013, he was appointed to the role of AE International Team Leader and International CEO. He has great experience working in cross-cultural contexts throughout Africa, in both Christian and business environments. He is a frequent speaker on the international stage, visiting AE support offices throughout the world in his role. Stephen has a passion for godly, Biblical leadership and a heart to see Africa transformed through the salvation of its people and the sound governance of its leaders. In Kenya, projects include Mathare Women's Tailoring Project and community-led sanitation initiatives.

## **Malawi**

**Mr Enoch Phiri**

Enoch has been working alongside AE since 1983, catching the vision to evangelise the cities of Africa with AE during the African Spiritual revival of the 1970s and 1980s. Prior to working with AE, Enoch spent 22 years with World Vision as the Christian Witness Coordinator. Enoch is a passionate speaker and evangelist on AE missions throughout the African continent, as well as on global tours. He has a passion to see lives transformed in Malawi. Current projects undertaken in Malawi include a Vocational Skills Training Project, and a Women's Rehabilitation and Retraining Centre at Lilongwe.

## **Rwanda**

**Mr John Kalenzi**

John has been the dynamic AE Rwanda Team Leader since 2008, having served on the Team before that since 2000. Having grown up in a refugee camp in Western Uganda, John understands the struggles of the marginalised and poverty stricken, and works through AE to bring peace, equality and reconciliation to Rwanda where people are still recovering from the genocide. Current projects include the Centre for Champions to equip disadvantaged youth with education, spiritual support and vocational skills, Self-Help Groups for Women to promote equality and small business ownership and many more.

## **South Africa**

**Mr Karabo Mokoape (Interim)**

Karabo was appointed as AE South Africa Interim Team Leader in 2016 in the wake of Michael Cassidy's step down from leadership. He has a degree in International Politics and attended Bible School for two years. He speaks Zulu, English, French and Spanish and is also the CEO of several businesses. He's served on the AE South Africa Board and has been mentored by Michael Cassidy. Karabo has a passion for mission and evangelism, and is overseeing numerous projects throughout South Africa, including a vibrant Foxfires Youth Team and frequent leadership training conferences.

## **Tanzania**

**Rev Wilfred Mmari**

Wilfred has been with AE as Team Leader for Tanzania for over 10 years, leading with gentle and quiet diligence. Many projects have been undertaken by the AE Tanzania Team, such as the HIV/AIDS education program in Magu, which has been particularly effective. HIV/AIDS is the dominant cause of adult mortality in Tanzania, affecting nearly 1.4 million people. Through the HIV program, Wilfred and AE Tanzania have built strong partnerships with the Tanzanian Government, specifically the Health Department and Ministry of Education, as well as local churches.

## **Uganda**

**Rev Paul Ssembiro**

Paul has been involved with AE for the last few years after a career in engineering and university lecturing. As the Team Leader of African Evangelistic Enterprise (AEE), he is currently focusing on mentoring upcoming evangelists, empowering the Church for ongoing urban evangelism, and raising a generation of leaders with integrity. His ministry also revolves around peace and reconciliation, helping to bridge the gap between communities affected by religious, tribal and political conflicts in the region. He's also been involved on a global level in politics, leading Uganda's delegation to the Lausanne III Congress in Cape Town in 2010. Paul is especially passionate about ministering to young people and professionals. Initiatives in Uganda include a medical clinic and city-wide missions.

## **Zimbabwe**

**Bishop Guide Makore**





## To the Members of African Enterprise Limited

### Report on the Audit of the Financial Report

#### Opinion

We have audited the financial report of African Enterprise Limited (the “registered entity”), which comprises the consolidated statement of financial position as at 31 December 2016, the consolidated statement of profit or loss and comprehensive income, consolidated statement of changes in funds and consolidated statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the Responsible Entities’ declaration.

In addition, we have audited African Enterprise Limited’s compliance with the requirements of the Charitable Fundraising Act 1991 and regulations, the Charitable Collections Act 1946 and the Charitable Collections Regulations 1947 (collectively referred to as the “Charitable Fundraising Acts”).

In our opinion:

- 1) the financial report of African Enterprise Limited has been prepared in accordance with Division 60 of the Australian Charities and Not-for-profits Commission Act 2012 (“ACNC Act”), including:
  - a) giving a true and fair view of the registered entity’s financial position as at 31 December 2016 and of its financial performance for the year then ended;
  - b) complying with Australian Accounting Standards and Division 60 of the Australian Charities and Not-for-profits Commission Regulation 2013;
- 2) the financial report gives a true and fair view of the financial results of fundraising appeals for the year ended 31 December 2016, the financial statements and associated records have been properly kept during the year in accordance with the Charitable Fundraising Act 1991 and regulations, and money received as a result of fundraising appeals conducted during the year has been properly accounted for and applied in accordance with this Act and the regulations; and
- 3) African Enterprise Limited has complied, in all material respects, with the requirements of the Charitable Collections Act 1946 and the Charitable Collections Regulations 1947 for the year ended 31 December 2016.

#### Basis for Opinion

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Report section of our report. We are independent of the registered entity in accordance with the auditor independence requirements of the ACNC Act and the ethical requirements of the Accounting Professional and Ethical Standards Board’s APES 110 Code of Ethics for Professional Accountants (the “Code”) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Responsibilities of Responsible Entities and Those Charged with Governance for the Financial Report

The Responsible Entities of the registered entity are responsible for the preparation and fair presentation of the financial report in accordance with Australian Accounting Standards, the ACNC Act, and the Charitable Fundraising Acts and for such internal control as the Responsible Entities determine is necessary to enable the preparation of the financial report that is free from material misstatement, whether due to fraud or error.

In preparing the financial report, Responsible Entities are responsible for assessing the registered entity’s ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Responsible Entities either intends to liquidate the registered entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the registered entity’s financial reporting process.

#### Auditor’s Responsibilities for the Audit of the Financial Report



As part of an audit in accordance with the Australian Auditing Standards, we exercise professional judgement and maintain professional scepticism throughout the audit.


We also:

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the registered entity’s internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by Responsible Entities.
- Conclude on the appropriateness of the Responsible Entities’ use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the registered entity’s ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor’s report to the related disclosures in the financial report or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor’s report. However, future events or conditions may cause the registered entity to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.




