Chairman's Report

AE's Silver jubilee year in 2022 marked 60 years since the founding of African Enterprise. It marked six decades of evangelising the cities of Africa in Word and Deed. It marked a lifetime of faithful service to God by our founder Dr Michael Cassidy.

Ecclesiastes 3:1 reminds us that "there is a time for everything and a season for every activity under the heavens". The past year has seen this time marked in several ways in Australia/New Zealand and the African continent.

With the departure early in the year of CEO Ben Campbell, it was time to welcome Jorge Rodrigues as our interim CEO. We are grateful to God for bringing him to AE and for his impact in his short time with us.

Before Simba commenced his role as CEO on the 23rd January, he stepped down as board director.

On an international front, many of you would have been informed of the missions and activities that culminated in the 60th-anniversary celebration in September in Lusaka, Zambia. We were blessed to have many Australian supporters attend missions, the prayer breakfast and the anniversary celebration.

The theme for the 2022 anniversary year – Holding True, Pressing On – reflects God's timing for every activity under the heavens again.



The achievements of the past 60 years were celebrated. Under Dr Michael Cassidy's leadership and mentorship, many faithful AE leaders and supporters have worked to change the lives of the people of Africa. Holding True to God's Gospel message, the cities of Africa have been evangelised in Word and Deed.

It was also recognised that, as the world changes, it is time to Press On, embracing this change in seeking new ways to reach the lost.

As Africa moves steadily towards being the continent with the largest population of evangelical Christians (by 2050), the urgency to share the Gospel message grows.



Lusaka 60th Anniversary Celebration & Mission

Holding true, pressing on.

African Enterprise's 60th Anniversary Celebration was held in Lusaka and hosted by AE (African Enterprise) Zambia. As a new office, AE Zambia also stepped up to lead its first international mission supported by our experienced national teams. The Lusaka mission in August/September 2022 partnered with 258 local churches and 1447 missioners from across Africa over an incredible ten days.

AE's stratified evangelism was deployed across Lusaka to ensure that as many people as possible could hear the Gospel from young professional forums, CEO squash tournaments, professional women's breakfasts, men's breakfasts, doctors' dinners, open market evangelism, street evangelism, door-to-door evangelism in the community, open-air meetings, and a National Prayer Breakfast for parliamentarians. 168,728 people were reached with the Gospel of Jesus, and 15,709 committed their lives to Christ.

How are you going to lead?

Michael Cassidy, AE Founder, was the keynote speaker for the National Prayer Breakfast at the Mulungushi International Conference Centre.

The event was well coordinated through leadership networks to arms of government, local churches, and AE. The Vice President of Zambia, Mrs Mutale Nalumango, was in attendance with Cabinet Ministers, elected Members of Parliament, members of the Judiciary, security services and other arms of government.

Michael Cassidy shared his wisdom on good governance and godly leadership. He shared from his extensive involvement as a Christian statesman who was involved in the peace negotiations in South Africa between the ANC and the Apartheid government just before the 1994 elections.

The country was on the brink of civil war – riots were common, and civil disobedience against the apartheid regime was increasing along with police brutality. Michael spoke of the great need for peace, forgiveness, truth, and reconciliation. He was not afraid to speak truth to power, although it was extremely dangerous. His strength came only from the Lord Jesus, whom he feared more than man. The church of South Africa was praying intensely for peaceful elections as Michael and other people that God used, including the Kenyan diplomat Washington Okumu continued to facilitate discussions that diffused the probability of civil war. Michael drew from the Word of God in these discussions, sharing scripture with leaders from

both sides. These negotiations led to the first democratic elections in 1994, in which Nelson Mandela won, and a peaceful transfer of power took place from the apartheid government to the ANC.

This story gripped the 300 attendees at the National Prayer Breakfast in Lusaka. Then Michael paused. He asked the leaders in the room, "How are you going to lead?" and drew back in silence. ►





When he returned to the microphone some moments later, he softly shared that the only way to lead people is to look up to the most outstanding leader that ever lived, who is Jesus Christ. He took our sins and died on the cross, and God raised him in victory. With great respect, he communicated the Gospel and encouraged people to fill out the decision cards on the tables to enable follow-up. And God moved.

On my recent trip to Zambia, seeing the fruit of the decisions and follow-up was very encouraging.

Six months after the Prayer Breakfast, there are now 30 parliamentarians meeting weekly to pray for one another and seek God's guidance for their leadership and governance. These leaders have also been connected to local churches for continued discipleship.

in Tailoring for Vulnerable Women

Evelyn Moses, a young woman from Malawi, faced a difficult start to her life, culminating in an unplanned teenage pregnancy. Empowering women in Ghana

African Enterprise Australia/New Zealand is pleased to report on the successful completion of a project in Ghana aimed at empowering women through bakery training.

The project was launched with the objective of recruiting five women for bakery training, providing them with training kits, and paying for their training fees. The training process was monitored to ensure effectiveness and regular progress reports were submitted to African Enterprise.

We are thrilled to report that all five women completed the bakery training program successfully. They were provided with the tools and resources necessary for success throughout the training process.

AE partnered with the Hopespring Foundation to provide valuable training for aspiring entrepreneurs. During the training, participants were introduced to various types of bakeries and the additional benefits of preparing fruit drinks and learning about effective marketing techniques. The training was conducted in Accra, and women from diverse locations were selected to participate. In addition to learning the basics of entrepreneurship, the training covered essential topics such as costing, packaging, and marketing. AE is proud to have played a role in empowering these women to pursue their dreams and create successful businesses.

The beneficiaries were also provided with support to set up their businesses. They were able to provide for themselves and their families, which is a significant achievement.

Additionally, Patience Quaye, Director of the Anti-Human Trafficking Unit of the Ghana Police Service, visited the women participating in our program. During her visit, she shared essential insights on protecting themselves from criminal activity with the group. She also provided the women with valuable self-affirmation advice, which helped boost their confidence levels. The beauty of Stratified Évangelism

African Enterprise has been at the forefront of evangelism and discipleship across Africa for over five decades. AE employs a unique approach in its ministry: Stratified Evangelism and Discipleship. This approach has enabled the organisation to reach people across different demographics, cultures, and social backgrounds.

Stratified Evangelism and Discipleship is an approach that recognises that people have different needs and, thus, require various forms of engagement. AE employs this approach by first identifying other groups of people in a community and understanding their unique needs. This may involve conducting research, surveys, or working with local leaders to understand the community's dynamics. Once the different groups have been identified, AE tailors its evangelism and discipleship approach to meet the specific needs of each group.

One of the most remarkable aspects of Stratified Evangelism and Discipleship is that it allows AE to engage with people in their local context. This approach recognises that people are more likely to embrace the Gospel when presented in a way relevant to their lives. Thus, AE's

A deep commitment to the Gospel is at the heart of AE's Stratified Evangelism and Discipleship approach. The organisation recognises that the Gospel is the power of God that transforms lives and communities. Thus, its programs are designed to present the Gospel clearly, compellingly, and transformatively. This has led to countless lives being transformed across Africa as people have come to know Jesus Christ as their Lord and Saviour.







The Adama Proclamation Mission

As part of the Adama 2022 Proclamation Mission, AEE (African Evangelistic Enterprise) organises couple's meetings to strengthen the family as a foundation for a healthy church and society. It is also preparing the seedbed for mission continuity in the area.

The stronger the family and the more aware it is of the stratified approach to missions, the higher the likelihood for mission continuity in that community. Most of the couples participating in the meeting are pastors and have been walking along with AEE in preparing the Adama 2022 Mission.

The training focused on the sanctity of marriage and family life.

One of the primary challenges of the church in the 21st century is family life. Satan has waged war to disgrace the biblical meaning of marriage and to destabilise the family. The training also emphasised the need for bringing up children with the fear of the Lord. A strong family means a strong church and a strong reputation for the church. The participants expressed their delight in participating in this important meeting. They said, "We, as leaders and ministers of the church in Adama, are very grateful to AEE for holding such a relevant and timely topic. The seminar has been applicable and edifying."

Lidya is one of the coordinators of the Adama Mission. She is a pastor in a local church and has a zeal for evangelism. She comes from a Muslim background and is committed to making Jesus known to the people around her. Lidya says, "the evangelists and volunteers have gathered together to pray before the start of the Proclamation week. Gospel preaching gets strength when it is supported by prayer. Evangelism and prayer go together. Every day, when the missioners go out to

evangelise, we assign prayer warriors to fight the good fight (spiritual warfare) and open the gates of people's hearts for the Gospel. In that way, we succeed."



The response of the people who listen to the Gospel

preached is encouraging. As we go out to the marketplace, there are challenges. The Gospel is ever powerful, and it is unfailing might to conquer, "we are more than conquerors through Him who loved us" (Rm 8:37).

As we engage in spiritual warfare, we need to make prayer part of evangelism and team up with "prayer warriors" as we go out to the different sites.



We took these from the book of Luke 2:52: "Jesus grew in wisdom, stature, and favour with God and Men".


